Privacy Notice – Liberation Day Hamper Scheme

This is the privacy notice details of the Liberation Day Hamper Scheme, which is being run by Collas Crill LLP, in conjunction with the States of Guernsey's Committee *for* Education, Sport & Culture.

Background

Individual Liberation Day tea hampers will be available for the older generation of our community who currently live alone or with family to celebrate the Island's freedom from German Occupation.

The hampers are available to:

Residents of the population who were living in Guernsey during the Second World War, who are aged 80 and over and living in private accommodation or with family.

You can register for a hamper for yourself or a carer/friend/member of your family to whom you give consent to apply and collect on your behalf, can register between Monday 10 April and Monday 1 May (calls and emails will not be monitored on Banks Holidays).

The hampers will be available for collection by either the recipient or a nominated carer from Beau Sejour between 9.30am and 1pm on Monday 8 May.

(<u>Please note</u> - Those islanders who were living in Guernsey during the Second World War and who are aged 80 and over BUT who are residents of care homes will have hampers delivered to them in a separate initiative which is being organised by Guernsey Post.)

The Data Protection Law

Collas Crill LLP is the registered Data Controller for all activities summarised within this notice. Sharing of data

The Controller will hold the data securely and will not share it with any third parties (including the Committee *for* Education, Sport & Culture) without consent unless the Controller is required to by law. No data will be shared with any unauthorised jurisdiction.

Storage and retention

The data will be kept by Collas Crill LLP for a period of eight days after the 8 May collection date, and will be deleted on 16 May 2023, once the scheme has ended.

Your information will not be shared with any third parties.
